II. Proof of Data Subject's Identity

We require proof of your identity before we can respond to your erasure request. To help us establish your identity, you must provide identification that clearly shows your name, date of

birth, and current address.

For example, we accept a photocopy or a scanned image of one of the following as proof of identity: passport or photo identification such as a driver's license, national identification number card, or birth or adoption certificate. If you have changed your name, please provide the relevant documents evidencing the change. We accept a photocopy or a scanned image of one of the following as proof of address: current driver's licence, utility bill, property tax receipt, or voter registration card. It is ok to remove information on the document that we do not need to verify your identity or address.

We may request additional information from you to help confirm your identity and your right to erasure.

To help us process your request quickly and efficiently, please provide as much detail about the personal data you are requesting erasure of and the above ground or grounds you are relying on to request erasure of your personal data.

We will contact you for additional information if the scope of your request is unclear or does not provide sufficient information for us to conduct a search (for example, if you request erasure of "all information about me").

Applicable law may allow or require us to refuse to act on your request, or we may have destroyed, erased, or made your personal data anonymous in accordance with our record retention obligations and practices. If we cannot honor your erasure request, we will inform you of the reasons why, subject to any legal or regulatory restrictions.

We will begin processing your erasure request as soon as we have verified your identity and have all of the information we need to locate your relevant personal data.
